**RECOMMENDING THE AWARD OF CONTRACT FOR A HIGHLY TECHNICAL
CONSULTANT ON DIGITAL INVESTIGATIONS AND FORENSICS (APP ITEM NO. 2022-
0134) FOR THE COMPLAINTS AND INVESTIGATION DIVISION**

WHEREAS, the National Privacy Commission (NPC) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, to effectively implement this mandate, the Complaints and Investigation Division (CID) needs to on board a well-rounded highly technical individual consultant, with adequate ground experience and expertise to develop strategies, to determine gaps, to improve and enhance the current processes, to provide mentoring as to impart learning and cultivate skillset, to identify tools and skills required to intensify the team's performance on the processes mentioned, and to craft documents relative to the CID operations and processes for the development of manuals, policies, standard procedures, guidelines, etc.;

WHEREAS, the Highly Technical Consultant shall undertake the functions indicated in the Terms of Reference herein attached as Annex "A";

WHEREAS, said procurement is reflected and has been approved in the Commission's CY 2021 Continuing Annual Procurement Plan (APP) under Item Number 2021-0187 with an Approved Budget for the Contract (ABC) amounting to **Seven Hundred Twenty Thousand Pesos (Php 720,000.00)**;

WHEREAS, said procurement is hinged on Section 53.7 of the Implementing Rule and Regulations of Republic Act No, 9184, otherwise known as the Government Procurement Reform Act, providing for the engagement of individual consultants for no more than six (6) months, to do work that is highly technical or proprietary;

WHEREAS, the CID evaluated the qualifications, expertise and extensive experience of Mr. Raymond C. Nunez / Mr. Raymond C. Nuñez and has determined that Mr. Nuñez is highly qualified to provide the CID with highly technical consultancy services that will aid in the development and processes of the CID Forensic Laboratory and technical investigations conducted on behalf of the National Privacy Commission;¹

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat sent a Request for Quotation (RFQ) to Mr. Raymond C. Nunez / Mr. Raymond C. Nuñez on 8 July 2022;


