**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF  
KEY PRIVACY THEMES VIDEO DEVELOPMENT AND PRODUCTION  
MANAGEMENT TO PROJECT V MEDIA CORP., THE DECLARED SINGLE RATED  
AND RESPONSIVE BIDDER**

---

**WHEREAS**, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

**WHEREAS**, the NPC, pursuant to its objective to build a culture of privacy, and to enable and uphold the right to data privacy and protection, identified 10 key issues that pose the greatest data privacy risks to citizens, coined as the Key Privacy Themes (KPT);

**WHEREAS**, to inform the general public of the importance of these issues, the NPC deemed it necessary to hire a production team to create short informational videos for each KPT which are targeted to be posted on the NPC official website and current popular platforms such as Facebook, Instagram, among others. These videos' target audience are the data subjects, thereby the content must be easy to understand, accessible to the public, and relevant. This procurement is under APP Item No. 2021-0167 with an approved budget for contract (ABC) amounting to Php1,500,000.00;

**WHEREAS**, this item of procurement is under the mode of Competitive Bidding, pursuant to Section 10, Rule IV of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184);

**WHEREAS**, on 14 October 2021, the National Privacy Commission-Bids and Awards Committee (NPC-BAC) conducted a pre-procurement conference where the Terms of Reference were reviewed and the number of shortlisted consultants including the criteria and rating for the shortlisting were set;

**WHEREAS**, on 21 October 2021, the Request for Expression of Interest (REI) was posted in the PhilGEPS and NPC websites, as well as on the NPC bulletin board. The Bidding Documents were also made available on the same date. Invitations to observers were also sent in accordance with Section 13 of the Revised IRR of R.A. 9184;

**WHEREAS**, the NPC-BAC set the deadline of submission of eligibility documents on 28 October 2021 at 10:00 a.m. An instruction on adoption of the procedure for the electronic submission and receipt of the eligibility documents in accordance with the NPC-BAC Guidelines on Electronic Submission and Receipt of Bids (Guidelines) was also provided in the Bidding Documents;

**WHEREAS**, the BAC declared failure of bidding due to non-receipt of eligibility documents;

**WHEREAS**, on 29 October 2021, the BAC conducted a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, and after some minor changes on the Terms of Reference, was endorsed for re-posting;

**WHEREAS**, 05 November 2021, the Request for Expression of Interest (REI) and Bidding Documents were re-posted in the PhilGEPS and NPC websites, as well as on the NPC bulletin board. Invitations to observers were also sent in accordance with Section 13 of the RIRR of R.A. 9184;

**WHEREAS**, the BAC set the deadline of submission of eligibility documents on 12 November 2021 at 10:00 a.m. An instruction on adoption of the procedure for the electronic submission and receipt of the eligibility documents in accordance with the NPC-BAC Guidelines on Electronic Submission and Receipt of Bids (Guidelines) was also provided in the Bidding Documents;

**WHEREAS**, on 12 November 2021, the BAC only received one submission for the eligibility documents from Project Media V Corp. at exactly at 08:54 a.m.;

**WHEREAS**, on 12 November 2021 at 01:00 p.m., the BAC proceeded to open the eligibility documents and conduct eligibility check of the prospective bidder in accordance with Section 24.4 of the Revised IRR of R.A. 9184;

**WHEREAS**, upon inspection and evaluation of the eligibility requirements submitted, it was determined that Project Media V Corp. passed all the eligibility requirements, as reflected in the Abstract of Eligibility Check attached here in as Annex "A", and was declared eligible;

**WHEREAS**, the NPC-BAC proceeded to conduct the short listing of the eligible prospective bidder in accordance with Section 24.5 of the Revised IRR of R.A. 9184, after rating the eligible prospective bidder based on the criteria and rating stated in the REI and the bidding documents, the prospective bidder acquired an over-all rating of 82.75% which is above the prescribed passing rate of 70%, as reflected in the Abstract of Short Listing attached herein as Annex "B", and was recommended to the Head of the Procuring Entity (HoPE) as the sole short-listed consultant;

**WHEREAS**, the HoPE approved the recommendation of the BAC to declare Project Media V Corp. as a short-listed consultant;

**WHEREAS**, on 23 November 2021, the Pre-bid Conference was conducted where the prospective bidder clarified some items in the Bidding Documents. Thereafter, the NPC-BAC issued Supplemental Bid Bulletin No. 137-2021, a copy of which was furnished to the prospective bidder and published in the PhilGEPS website, NPC website and bulletin board;

**WHEREAS**, on 7 December 2021, prior to the deadline of submission of the bids set at 10:00 a.m., Project V Media Corp. submitted their bid at 9:58 a.m. On the same day at 1:00 p.m., the NPC-BAC proceeded to open the first envelope containing the technical components for the conduct of preliminary evaluation where it was declared that Project V Media Corp. passed all the technical documents required as shown in the Abstract of Bids as Read attached herein as Annex "C" and was then endorsed for bid evaluation;

**WHEREAS**, on 9 December 2021, the technical proposal of Project V Media Corp. was evaluated based on the criteria and numerical weights as stated in the Bidding Documents, where it was given an overall rating of 84%, above the passing rate of 80% as shown in the Abstract of Bids (Technical Rating) attached herein as Annex "D", and was endorsed for the opening of Financial Proposal;

**WHEREAS**, on 10 December 2021, the financial proposal envelope of Project V Media Corp. was opened and evaluated and the proposed bid price of Php 1,319,310.00 was recorded, and being the sole bidder, its financial proposal was given a rating of 100% as shown in the Abstract of Bids (Financial Rating) herein attached as Annex "E";

**WHEREAS**, using Quality-Cost Based Evaluation Procedure in accordance with Section 33.2.1 (b) of the Revised IRR of R.A. 9184, the technical and financial proposals were then rated at a weight ratio of 80% for the Technical Proposal and 20% for the Financial Proposal as provided in the Bidding Documents;

**WHEREAS**, upon computation of the ratings given by the NPC-BAC, it was determined that the over-all rating obtained by Project V Media Corp.'s bid is 87.2% (67.2% for the technical proposal and 20% for the financial proposal), passing the technical and financial requirements and making it the single rated bid as shown in the Abstract of Bids as Calculated herein attached as Annex "F", and was recommended for the conduct of negotiation;

**WHEREAS**, the HoPE approved and authorized the conduct of negotiation which was conducted on 14 December 2021 where the NPC-BAC, TWG and the End-user proceeded to negotiate with the representative of Project V Media Corp. and the discussions on issues raised and agreements reached were recorded in preparation of the drafting of the contract;

**WHEREAS**, upon termination of the negotiation, the BAC endorsed the bid for post-qualification evaluation;

**WHEREAS**, on 17 December 2021, the NPC-BAC proceeded to review the Post-Qualification Report submitted by the BAC-TWG, herein attached as Annex "G", and adopted the same, noting the recommendations made therein;

**WHEREAS**, there being no issues in the BAC-TWG's Post-Qualification Report, it was moved and seconded to declare the bid by Project V Media Corp. as the Single Rated and Responsive Bid and recommend it for the award of contract;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, that Project V Media Corp., whose bid price is **One Million Three Hundred Nineteen Thousand Three Hundred Ten and 0/100 Pesos** (Php1,319,310.00), be declared as the single rated and responsive bidder and be recommended for the award of contract for the procurement of Key Privacy Themes Video Development and Production Management;





**MEMORANDUM OF AGREEMENT**

**KNOWN ALL MEN BY THESE PRESENTS:**

This AGREEMENT made and entered into this 31 December 2021 by and between:

**NATIONAL PRIVACY COMMISSION**, a national government agency created by virtue of Republic Act No. 10173 or the "Data Privacy Act of 2012", with office address at the 5<sup>th</sup> Floor, Philippine International Convention Center, Vicente Sotto Street, Pasay City, Metro Manila, represented by its Privacy Commissioner **ATTY. JOHN HENRY D. NAGA** hereinafter referred to as "**NPC**",

and

The **PROJECT V MEDIA CORP**, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office address at Unit 404 Don Raul Bldg., 77 Kamuning Rd., Kamuning Quezon City, represented herein by its Project Manager, **ROSANNE BERNADETTE CHUA**, and hereinafter referred to as "**CONSULTANT**".

The NPC and the **CONSULTANT** shall hereinafter be referred to collectively as the "**PARTIES**."

**WITNESSETH, that:**

**WHEREAS**, the NPC, pursuant to its objective to build a culture of privacy, and to enable and uphold the right to data privacy and protection, identified 10 key issues that the pose greatest data privacy risks to citizens, coined as the Key Privacy Themes (KPT);

**WHEREAS**, to inform the general public of the importance of these issues, the Office of the Privacy Commissioner (OPC) as end-unit deemed it necessary to hire a Key Privacy Themes Video Development and Production Management as per existing laws and regulation to create short informational videos for each KPT which are targeted to be posted on the NPC official website and current popular platforms such as Facebook, Instagram, among others;

**WHEREAS**, on 14 October 2021 the NPC Accountant issued Certificate of Availability of Funds (CAF) amounting Php1,500,000.00. A copy of the CAF is hereto attached as ANNEX "A" and made an integral part of this Agreement;

**WHEREAS**, NPC has expressed their requirement for a service provider for Key Privacy Themes Video Development and Production Management, through the Philippine Government Electronic Procurement System (PhilGEPS);

**WHEREAS**, **CONSULTANT** has participated in the bidding process of a Competitive Bidding for the abovementioned project by submitting a quotation and other pertinent documents;

WHEREAS, CONSULTANT will provide services set forth below and in the Terms of Reference<sup>1</sup>, which are to be herein collectively referred to as the "SERVICES";

WHEREAS, CONSULTANT has presented itself to NPC as having the knowledge, competence and skill which are necessary and indispensable in carrying out the SERVICES set forth herein;

WHEREAS, NPC, subject to the terms, conditions, and specifications hereinafter contained, has accepted the CONSULTANT'S offer;

WHEREAS, on 23 December 2021, the Head of the Procuring Entity approved the NPC-BAC Resolution No. 191-2021, Series of 2021, recommending the Award of Contract for Key Privacy Themes Video Development and Production Management to Project V Media Corp.;

WHEREAS, on 23 December 2021, the Head of the Procuring Entity issued the Notice of Award to Project V Media Corp, attached as "Annex B"

NOW, THEREFORE, for and in consideration of the foregoing premises, the mutual covenants and conditions herein contained and other good and valuable considerations, the parties hereto mutually agree as follows:

**1. Services**

The CONSULTANT shall perform and provide all that is necessary to carry out the services necessary to complete the same. The details of the services, scope of work, duties and responsibilities, among others, appear in the attached Terms of Reference, herein attached as Annex "C", which forms an integral part hereof.

**2. Term**

The term of the contract shall commence January 2, 2022 until 15 March 2022 unless the same is terminated by either party after written notice thirty (30) days prior to the intended date of termination or immediately upon proof of violations prescribed under Annex "I" of Implementing Rules and Regulations of Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" (IRR of R.A. No. 9184.)

### 3. Payment

#### A. Consultant's Fee

As consideration for the full and faithful performance by the **CONSULTANT** of his obligations under this Agreement and the completion of the services in accordance with the terms and conditions herein set forth, **NPC** shall pay the **CONSULTANT** a total amount of One Million Three Hundred Nineteen Thousand Three Hundred Ten Pesos (Php1,319,310.00) inclusive of all applicable taxes, duties, fees, levies and other charges imposed under applicable laws.

The contract price shall constitute the entire remuneration payable to the **CONSULTANT**. It shall be deemed inclusive of all applicable national and local taxes, fees and charges, and any other taxes that may arise on account hereof.

#### B. Payment of Services

Payment shall be made in Philippine Pesos in equal payments, upon submission of the following documents and deliverables:

- i. Accomplishment Report; and
- ii. Certificate of Acceptance of Output by the end-user.

All payments will be subject to the usual government accounting and auditing rules and regulations.

- 4. Project Administration** NPC designates Head Executive Assistant Erwin D. Espenilla, as the Representative responsible for the coordination of activities under the contract. The Head Executive Assistant shall be responsible for acceptance of the deliverables/Accomplishment Report submitted by the Consultant prior to payment.
- 5. Performance Standard** The **CONSULTANT** undertakes to perform the services detailed in Annex "C" herein, with the highest standards of professional and ethical competence and integrity.
- 6. Confidentiality** The **CONSULTANT** shall not, during the term of this Contract, and after its expiration, disclose any proprietary or confidential information relating to the services, this Contract or NPC's business or operations without the prior written consent of the latter.
- 7. Non-Disclosure** All non-public confidential or proprietary information relating to NPC, whether written or oral, whether or not communicated as confidential information by NPC to the **CONSULTANT**, which the **CONSULTANT** may have access to in the course of the consultancy services contract, shall not be disclosed to any person even after the termination of the Contract.
- The **CONSULTANT** shall sign a Non-Disclosure Agreement which shall form part of this contract.<sup>2</sup>
- 8. Amendments** No modifications, amendments, or supplements to this Contract shall be effective for any purpose unless the same is in

writing and signed by each party.

**9. Suspension of Contract**

NPC may, by written notice of suspension to the **CONSULTANT**, suspend all payments to the **CONSULTANT** if the **CONSULTANT** fails to perform any of its obligations due to its own fault or due to force majeure or other circumstances beyond the control of either party, provided that such notice of suspension: a) Shall specify the nature of the failure; and b) Shall request the **CONSULTANT** to remedy such failure within a period not exceeding thirty (30) days after receipt by the **CONSULTANT** of such notice of suspension.

The Procuring Entity can order the resumption of work if the grounds for work suspension no longer exist and the continuation of the work is practicable.

**10. Termination of Contract**

NPC, by written notice sent to the **CONSULTANT**, may terminate the contract, in whole or in part in accordance with Annex "I" of IRR of RA No. 9184.

The notice of termination shall specify the cause of termination in accordance with Annex "I" of IRR of RA No. 9184, the extent to which performance of the contractor under the contract is terminated, and the date upon which such termination becomes effective.

NPC may also terminate the contract in case it is determined prima facie that the **CONSULTANT** has engaged, before or during the implementation of the contract, in unlawful deeds and behaviors relative to contract acquisition and implementation.

NPC may also terminate a contract for default when any of the following conditions attend its implementation: a) Outside of force majeure, the **CONSULTANT** fails to deliver or perform the Outputs and Deliverables within the period(s) specified in the contract, or within any extension thereof granted by the NPC pursuant to a request made by the **CONSULTANT** prior to the delay; b) As a result of force majeure, the **CONSULTANT** is unable to deliver or perform a material portion of the Outputs and Deliverables for a period of not less than sixty (60) calendar days after the **CONSULTANT'S** receipt of the notice from NPC stating that the circumstance of force majeure is deemed to have ceased; or c) The **CONSULTANT** fails to perform any other obligation under the contract.

The **CONSULTANT** may terminate its agreement with NPC if the latter is in material breach of its obligations pursuant to the

contract and has not remedied the same within sixty (60) calendar days following its receipt of the **CONSULTANT'S** notice specifying such breach.


Termination of contract encompasses all causes and grounds provided under RA No. 9184.


- 12. Relationship** This Contract neither constitutes a partnership agreement nor creates an employer-employee relationship, joint venture, or agency relationship between parties. It is specifically understood that the **CONSULTANT** is an independent contractor and shall not be considered as an employee of NPC.
- 13. Dispute Resolution** In the event of any dispute or difference of any kind whatsoever arising out of or relating to this Contract, both parties shall exercise their best efforts to resolve the dispute or difference by mutual consultation as soon as possible. In case best efforts fail, the dispute or difference shall be submitted to alternative dispute resolution, including arbitration in accordance with the rules provided in Republic Act No. 9285 or the Alternative Dispute Resolution Law.
- If any party contends that a claim cannot be submitted to alternative dispute resolution, that party shall be limited to filing a lawsuit in the appropriate courts in Pasay City, Philippines, to the exclusion of all courts.
- 14. Ownership of Material** All articles, plans, studies, reports or other materials prepared by the **CONSULTANT** for NPC under the Contract shall exclusively belong to and remain the property of NPC.
- 15. Consultant Not to be Engaged in Certain Activities** The **CONSULTANT** agrees that, during the term of this Contract and after its termination, the **CONSULTANT** and any entity/individual affiliated with the **CONSULTANT**, shall be disqualified from providing goods, works or services (other than the services or any continuation thereof) for any project resulting from or closely related to the herein services provided to NPC.
- 16. Insurance** The **CONSULTANT** will be responsible for taking out any appropriate insurance coverage.
- 17. Assignment** The **CONSULTANT** shall not assign this Contract or subcontract any portion of it.
- 18. Law Governing Contract and Language** The Contract shall be governed by the laws of the Government of the Philippines, and the language of the Contract shall be English.
- 19. Other Provisions** The **PARTIES** agreed that duly approved Terms of Reference, Financial Proposals, and all the bidding documents in relation


to this procurement are deemed integral part if this Agreement.


