**RECOMMENDING THE AWARD OF CONTRACT FOR ANNUAL EMPLOYEES'
APPRECIATION DAY: CATERING SERVICES**

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, in line with the approval of the Policy Guidelines on Awards and Incentives for Service Excellence (PRAISE) of the NPC, all deserving employees will be recognized and rewarded with monetary and non-monetary incentives during the Annual Employees' Appreciation Day;

WHEREAS, there is a need to procure catering services for the conduct of said event;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing in the FY 2021 Appropriations (RA 11518), programmed under the NPC FY 2021 APP Item No. 2021-0186 and with Approved Budget for the Contract (ABC) amounting to Php75,000.00;

WHEREAS, Section 50(c) of R.A. 9184 allows Direct Contracting for items which are sold by a provider who does not have any sub-dealer selling the product at a lower price and for which no suitable substitute can be obtained at more advantageous terms to the Government;

WHEREAS, to justify the need to procure through Direct Contracting, the end-user stated in its justification that pursuant to the Lease Agreement entered into between the PICC and NPC on 03 August 2017, Item No. 14 specifically stated that, "*The LESSEE shall not be allowed to bring in, for large or extraordinary events or celebrations, catered food and beverages inside the Leased Premises, since LESSOR has an exclusive food concessionaire. Accordingly, LESSEE may, as far as practicable, make arrangements with such concessionaires for the food and beverage requirements for its needs.*" Consequently, the NPC as the LESSEE shall avail catering services from the exclusive food concessionaire, Via Mare Corporation;

WHEREAS, pursuant to said justification, a Request for Quotation (RFQ) was sent to Via Mare Corporation on 13 December 2021;

WHEREAS, on 14 December 2021, Via Mare Corporation sent its quotation in the total amount of Seventy-Five Thousand and 0/100 Pesos (Php75,000.00);

WHEREAS, on the same day, the National Privacy Commission-Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotation by Via Mare Corporation and


