**RECOMMENDING THE AWARD FOR THE PROCUREMENT OF
NETWORK ATTACHED STORAGE**

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, Section 9(c) of the Implementing Rules and Regulation (IRR) of the DPA provides as one of NPC's function is to undertake necessary or appropriate efforts to inform and educate the public of data privacy, data protection, and fair information rights and responsibilities;

WHEREAS, the Public Assistance and Information Division (PIAD) is responsible for information management, including publications and website maintenance, and the provision of public services in the NPC;

WHEREAS, the procurement of Network Attached Storage (NAS) is to aid PIAD in storing all its digital resources and backups and will allow the retrieval of files using a different device and guarantees the availability of resources whenever needed. This procurement is under NPC APP FY 2021 with item No. 2021-0058 with an Approved Budget for the Contract (ABC) in the amount of Php400,000.00;

WHEREAS, Section 53.9 of the Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Small Value Procurement (SVP) as a mode of procurement for goods where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, on 03 December 2021, a Request for Quotation (ROQ) setting the deadline for submission of quotation on 07 December 2021 (05:00 PM), was posted in the PhilGEPS website, NPC website, and the NPC bulletin board, and was likewise sent to eight (8) suppliers via electronic mail, namely: Maxcor Inter-ventures Co., Provantage Systems Inc., Imax Technologies Inc., Cron Enterprise, Otus Copy Systems, Inc., BayanPC Technologies Inc., Solid Business Machine Center Incorporated, 16/35mm Production Supply who all failed to submit their quotations;

WHEREAS, despite non-submission by the invited suppliers, a quotation was received from another supplier, Alpha Digizone Marketing;

WHEREAS, the BAC, after evaluating the submitted quotation and documents, found Alpha Digizone Marketing eligible;

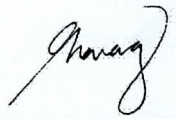



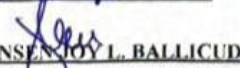
