Resolution No. 031-2022, Series of 2022

**RECOMMENDING THE AWARD OF REPRESENTATION  
IN RELATION TO THE PRIVACY AWARENESS WEEK 2022  
TO VIA MARE CORPORATION THROUGH DIRECT CONTRACTING**

---

**WHEREAS**, pursuant to Section 9 (c) of the Implementing Rules and Regulations (*IRR*) of Republic Act No. 10173, otherwise known as the Data Privacy Act of 2012, the National Privacy Commission ("*NPC*" or the "*Commission*") is mandated to undertake necessary or appropriate efforts to inform and educate the public about data privacy, data protection, and fair information rights and responsibilities;

**WHEREAS**, the issuance of Proclamation No. 527 on the 3<sup>rd</sup> day of July 2018 by President Rodrigo R. Duterte declaring the last week of May of every year as the National Data Privacy Awareness Week strengthens NPC's effort in informing the public about data privacy and protection, and fair information rights and responsibilities;

**WHEREAS**, to aid the Commission in the aforementioned purpose, a two-day National Data Privacy Conference will be conducted on 25-26 May 2022 as the Commission's flagship event to celebrate the Privacy Awareness Week (*PAW*) 2022 as the gathering of Data Protection Officers, privacy professionals and advocates to discuss industry-specific issues and capacitate stakeholders with the necessary skills and knowledge;

**WHEREAS**, accordingly, the Office of the Privacy Commissioner (*OPC*), as end-user, proposed procurement of representation for the two-day National Data Privacy Conference as approved by the Head of the Procuring Entity, as per Purchase Request (*PR*) No. 2022-05-0066, with an approved budget for the contract of Php 180,000.00;

**WHEREAS**, Section 50 of Republic Act No. 9184, also known as the Government Procurement Act, (R.A. 9184) allows Direct Contracting as an alternative mode of procurement;

**WHEREAS**, Annex "H" of the 2016 Revised Implementing Rules and Regulations of R.A. 9184 provides for the guidelines for Alternative Modes of Procurement including Direct Contracting, hereby attached as Annex "A";

**WHEREAS**, Memorandum Circular No. 14 dated 14 February 2017 issued by the Office of the President, provides that government agencies shall give preference to the facilities of the Philippine International Convention Center (*PICC*) in holding official activities and events, hereby attached as Annex "B";

**WHEREAS**, Section 14 of the Contract to Lease between the NPC and the PICC provides that, "*The LESSEE shall not be allowed to bring in, for large or extraordinary events or celebrations, catered food and beverages inside the Leased Premises, since LESSOR has an exclusive food concessionaire. Accordingly, LESSEE may, as far as practicable, make arrangements with such concessionaire for the food and beverage requirements for its needs.*" A copy of the Contract is hereby attached as Annex "C".

**WHEREAS**, the PICC has an exclusive food concessionaire, Via Mare Corporation, and does not allow the outsourcing of a catering service provider, as evidenced by the Certification issued by the PICC, hereby attached as Annex "D";

**WHEREAS**, on 16 May 2022, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) evaluated the submission of Via Mare Corporation and determined that it passed all the technical, legal, and financial requirements under RA 9184 and its 2016 Revised Implementing Rules and Regulations;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of REPRESENTATION for the Privacy Awareness Week 2022 to **VIA MARE CORPORATION** through Direct Contracting in the total amount of **ONE HUNDRED FIFTY-SIX THOUSAND PESOS (PHP 156,000.00)** subject to the presentation of its original documentary requirements upon signing of the Notice of Award (NOA).
