BAC Resolution No. 019-2021, Series of 2021

RECOMMENDING THE AWARD OF THE CONTRACT FOR SMTP RELAY-BULK EMAIL SERVICE

WHEREAS, the National Privacy Commission (NPC) is a Procuring Entity (PE) mandated by law to meticulously and judiciously plan its budget consistent with government fiscal discipline measures;

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, NPC's Compliance Monitoring Division (CMD) is mandated to monitor and ensure compliance of personal information controllers and processors with its obligations under the Data Privacy Act of 2012 (DPA) and its Implementing Rules and Regulations. In compliance of this mandate, CMD is developing the Data Breach Notification Management Systems (DBNMS) and an online registration system that will allow efficient delivery of services;

WHEREAS, to better deliver transactional emails such as temporary passwords, password resets and delivery confirmation to the untended email addresses, an SMTP relay service can help NPC deliver transactional emails without being mislabeled as spam and aids in overcoming e-mail sending limits;

WHEREAS, using an SMTP relay service to send email relieves the burden of dealing with email delivery issues, IP blacklisting as well as minimizing reputational problems whenever email messages silently go to either spam or junk folder, NPC-CMD proposed to outsource the services to an SMTP Relay Service Provider under APP Item No. 2020-0202 with Approved Budget for the Contract (ABC) amounting to Php200,000.00;

WHEREAS, Section 53.9 of the Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Small Value Procurement (SVP) as a mode of procurement for goods where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, a Request for Quotation was posted in the PhilGEPS website, NPC website, and the NPC bulletin board, and was likewise sent to eight (8) suppliers via electronic mail, namely: ZEP Network and Data Solution, My Creative Panda Web Design & Devt. Consultancy Services, MyBusyBee Inc., PurpleBug Inc., Teqware Corporation, Thinkbit Solutions Phils. Inc., Swara Sug Media Corporation, and Rechner Daten Technok Inc., which all failed to submit their quotation;

WHEREAS, three (3) bids, however, were received from Sophie's Information Technology Services, TMDC I.T. Solutions, and Terratek Business Consulting and Services, the BAC members proceeded to evaluate the submitted bid and determined that the lowest calculated and responsive quotation is that of Sophie's Information Technology Services at a bid price of Php 188,160.00, passing the technical, legal, and financial requirements mandated under RA 9184 and on terms that are most favorable to the government;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for SMTP Relay-Bulk Email Services to Sophie's Information Technology Services for passing all the required eligibility and for having the lowest calculated and responsive quotation in the total amount of One Hundred Eighty-Eight Thousand One Hundred Sixty and 0/100 Pesos (Php188,160.00).
