RECOMMENDING THE AWARD FOR THE ENGAGEMENT OF  
VAPT SPECIALIST

**WHEREAS**, the National Privacy Commission (NPC), is an independent body mandated to administer and implement Republic Act (R.A.) No. 10173 or the “Data Privacy Act of 2021” and to monitor and ensure compliance of the country with international standards set for data protection;

**WHEREAS**, the NPC currently has the following ongoing systems development projects: Case Management System (CMS), DPO ACE Automated Examination System (DPO ACE AES), and NPC Website Revamp (Content Management System);

**WHEREAS**, to ensure that these systems are secure and that vulnerabilities are addressed prior to deployment, it is imperative that all systems be subjected to vulnerability assessment and penetration testing; hence the need for a Highly Technical Consultant;

**WHEREAS**, the Highly Technical Consultant shall undertake the functions indicated in the Terms of Reference herein attached as Annex “A”;

**WHEREAS**, said procurement is under the General Appropriations Act FY 2021 (RA 11518) and has been approved in the Commission’s CY 2021 Annual Procurement Plan (APP) under APP Item Number 2021-0131 with an Approved Budget for the Contract (ABC) amounting to Five Hundred Fifty Thousand and 0/100 Pesos (Php550,000.00);

**WHEREAS**, the procurement is hinged on Sec. 53.7 of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184), otherwise known as Government Procurement Reform Act, providing for the engagement of individual consultants for no more than six (6) months to do work that is highly technical or proprietary;

**WHEREAS**, the NPC Bids and Awards Committee (BAC) Secretariat sent a Request for Quotation (RFQ) to *Mr. Benjie Brian A. Zamora* on 06 December 2021;

**WHEREAS**, after evaluation of the qualifications and documentary submissions of *Mr. Benjie Brian A. Zamora*, the NPC-BAC determined that he fully qualifies as a Highly Technical Consultant to perform said functions indicated in “Annex A”;


NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED to recommend the award of contract for the engagement of a VAPT Specialist in the total amount of Five Hundred Twenty-Six Thousand Four Hundred and 0/100 Pesos (Php526,400.00) to Mr. BENJIE BRIAN A.
