RECOMMENDING THE AWARD FOR PUBLICATION

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to enforce data privacy protection;

WHEREAS, the NPC, through the Compliance and Monitoring Division (CMD), aims to publicize in two (2) newspapers of general circulation the Data Protection Officer (DPO)/Data Processing Systems (DPS) Registration Announcement, in order to provide further information and assistance to PICs and PIPs in the designation and registration of their DPO;

WHEREAS, in line with the plan of automation of the process and management of breach notifications through the procurement of the Data Breach Notification Management System (DBNMS), the Commission likewise intends to publicize in two (2) newspapers of general circulation the Data Breach Management System Announcement;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing in the FY 2021 Appropriations (RA 11518), programmed under the NPC FY 2021 APP Item No. 2021-0086, with Negotiated Procurement through Scientific, Scholarly, Artistic Work, Exclusive Technology and Media Services as the mode of procurement, and an Approved Budget for the Contract (ABC) amounting to a total of Php300,000.00 (Php150,000.00 for each announcement);

WHEREAS, based on the conducted market study, The Manila Times Publishing Corporation and Concept & Information Group, Inc. have the lowest ad rates for a full/whole page ad that are within the ABC, as such they were asked to submit quotations;

WHEREAS, the BAC members proceeded to evaluate the submitted quotations and determined that The Manila Times Publishing Corporation and Concept & Information Group, Inc. both passed the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act, for both having the responsive quotations, at the bid price of Php128,217.60 and Php108,864.00, respectively, all terms being most favorable to the government;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the Head of the Procuring Entity (HoPE) for his consideration and approval, the award of contract for Publication to The Manila Times Publishing Corporation with a bid price of Php128,217.60, and Concept & Information Group, Inc., with a bid price of Php108,864.00, for a total bid price




