I. BACKGROUND

As the implementing body of the Data Privacy Act (DPA) of 2012, the National Privacy Commission holds its mandate to administer and implement the law accordingly. This encapsulates information and education on data protection of the public, including their fair information rights and responsibilities stated in Section 9.c of the Implementing Rules and Regulations of the DPA.

The Public Assistance and Information Division (PIAD) is responsible for information management, including publications and website maintenance, and the provision of public services in the Commission. To fulfill these tasks, the division will develop, implement, and organize various activities, programs, and projects. Another way for the division to effectively disseminate information is by producing presentations for visual campaigns of NPC.

In this regard, the division proposes to procure clickers that could be used for easier visual presentations for official campaigns and events by the NPC.

II. OBJECTIVES

The purpose of procuring clickers is to aid PIAD in promoting data privacy through various multimedia materials and visual presentations. The clickers will serve as the digital pointer that works in-person, virtually, or a hybrid of both. This will also help presenters to spotlight the important points and keep the presentation engaging and easy to follow.
