I. BACKGROUND

Recently, the National Privacy Commission issued several temporary bans against certain Online Lending Companies (OLCs). In line with the task of the Enforcement Division (EnD) to monitor and evaluate the compliance of these OLCs with the Commission's Order, it is necessary for the EnD to acquire cellular phones for the monitoring, analysis, and simulation of the OLCs' online lending applications, which may still be downloadable via different mobile application platforms like 1.) Google Playstore, 2.) Apple App Store, and 3.) Huawei AppGallery. Thus, the EnD is planning to procure test devices running in both Android and IOS platforms to perform the needed simulations for evaluations.

II. OBJECTIVES

The primary objective of procuring mobile phones is to monitor, analyze, and simulate mobile applications such as online lending applications, during technical investigation. Analysis of the applications include testing the user experience and verification of the compliances submitted, such as revisions and sandbox versions. Generated results will then serve as the basis in constructing the technical and enforcement assessment/action reports.


