I. BACKGROUND

The purchase of COLORED PRINTER, 3-IN-1, (Print-Scan-Copy) was recognized as essential to the performance of daily tasks of the NPC employees especially for the operations conducted in the field. It is used for reproducing important records and files for submission and compliance to oversight agencies, inter-office requirements including documents required during field work. This will also serve as back up for the high-volume multifunction printers of the Commission.

II. OBJECTIVES

To procure Colored Printer,3-in-1,(Print-Scan-Copy) in response to the general requirements of the NPC employees in the performance of their daily tasks inside and outside the NPC Office and compliance to oversight agencies.
