I. BACKGROUND

The purchase of FLOOR STANDING AIR CONDITIONER (INVERTER) was recognized as essential to the operations of the Commission. This is to be placed on the enclosed rooms/ offices which was not covered by the centralized aircon of the PICC. This will also serve as back up in cases that the PICC aircon is not available due to maintenance.

II. OBJECTIVES

To procure FLOOR STANDING AIR CONDITIONER (INVERTER) and provide conducive working environment that will be beneficial for both employees and clients of the Commission.
