## Publication of NPC issuances (APP Item No. 2023-0042)

### I. BACKGROUND

Section 2 of Republic Act No. 10173 otherwise known as the Data Privacy Act of 2012 (DPA) provides that it is the policy of the State to protect the fundamental human right of privacy while ensuring of free flow of information to promote innovation and growth. The State recognizes the vital role of information and communications technology in nation-building and its inherent obligation to ensure that personal information in information and communications systems in the government and in the private sector are secured and protected.

Pursuant to Section 7 of the DPA, the NPC is charged with the administration and implementation of the provisions of the law, which includes ensuring compliance with the provisions of the DPA and with international standards for data protection and carrying out efforts to formulate and implement plans and policies that strengthen the protection of personal information in the country, in coordination with other government agencies and the private sector.

The Privacy Policy Office (PPO), through its Policy Development Division, is particularly tasked to recommend and develop standards for organizational security measures for protection of personal information, including policies for the processing of sensitive information in government.

With this, the PPO aims to publicize in one (1) newspaper of general circulation an issuance of the Commission.

### II. OBJECTIVES

The NPC aims to publish in one (1) newspaper of general circulation an NPC issuance to be issued by the Commission in 2023 pursuant to Section 18 of Executive Order No. 292:

Section 18. When Laws Take Effect. - Laws shall take effect after fifteen (15) days following the completion of their publication in the Official Gazette or in a newspaper of general circulation, unless it is otherwise provided.

In addition, through this publication, the PPO will be able to contribute to the strategic objectives of *Empowered Data Subjects* and *Ensured world class data privacy standards established in the country*.

The publication shall also spread awareness with both the public and privacy sectors about the general data privacy principles, accountable processing of personal data, rights of the data subjects, and security of personal data.
