BAC Resolution No. 125-2022, Series of 2022

**RECOMMENDING THE APPROVAL OF THE AMENDMENT IN THE 2021  
CONTINUING ANNUAL PROCUREMENT PLAN OF THE NATIONAL PRIVACY  
COMMISSION**

---

**WHEREAS**, pursuant to the General Appropriations Act of Fiscal year 2021 (2021 GAA), the National Privacy Commission (NPC) approved its FY 2021 Annual Procurement Plan (APP);

**WHEREAS**, on 30 December 2021, the Congress of the Philippines enacted Republic Act No. 11640 (R.A. 11640), which extends the availability of the 2021 appropriations until 31 December 2022;

**WHEREAS**, the NPC-Bids and Awards Committee (NPC-BAC), after due deliberation and after assessing the status of the items for procurement in the 2021 APP, saw the need to avail of the extension afforded by R.A. 11640 and to declare the 2021 APP as a continuing APP, which shall be implemented until 31 December 2022;

**WHEREAS**, the NPC-BAC in Resolution No. 002-2022 recommended the Approval of the 2021 APP as Continuing APP for the fiscal year 2022;

**WHEREAS**, Section 7.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, provides that all procurement shall be within the approved budget of the Procuring Entity and should be meticulously and judiciously planned by the Procuring Entity;

**WHEREAS**, Section 7.4 of the same IRR provided that all changes to the consolidated APP, may be undertaken every six (6) months or as often as may be required by the Head of the Procuring Entity (HoPE);

**WHEREAS**, the NPC seeks to amend its existing approved FY 2021 Continuing APP to accurately reflect the procurements and projects of the Commission;

**WHEREAS**, the Administrative Services Division (ASD)<sup>1</sup> proposed the inclusion of the following APP items:

- (1) "Sound System with various accessories" with an estimated budget of Php 180,000.00;
  - (2) "Modular Conference Table with Chairs" with an estimated budget of Php 600,000.00;

(3) “Floor Standing Air Conditioner (Inverter)” with an estimated budget of Php 480,000.00;

WHEREAS, the Data Security and Compliance Office (DASCO)<sup>2</sup> proposed the inclusion of an APP Item for “Central Data Repository bundled with Encryption Hardware” with an estimated budget of Php 800,000.00;

WHEREAS, the Legal Division (LD)<sup>3</sup> proposed the inclusion of an APP Item for “Publication of the Draft circular on the amendments to NPC 2021 Rules of Procedure” with an estimated budget of Php 200,000.00;

WHEREAS, the Office of the Privacy Commissioner (OPC)<sup>4</sup> proposed the removal of “Publication of Circular on Amending certain provision of NPC Circular No. 20-01 on the Guidelines on the processing of personal data for loan-related transactions” (APP Item No. 2021-0185);

WHEREAS, the Office of the Executive Director (OED)<sup>5</sup> proposed the increase of the estimated budget for APP Item No. 2021-0215, “Consultancy Services – Technical Consultant” from Php 600,000.00 to Php 700,000.00;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby RESOLVE, as it is hereby RESOLVED, to recommend the approval of the Revised FY 2022 APP (as of 24 November 2022), a copy of which is herein attached as “Annex F”.
