## RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF HEALTH KITS

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the NPC approved its FY 2021 Continuing Annual Procurement Plan (APP) which includes the procurement of Health Kits under APP Item No. 2021-0218 with the Approved Budget for the Contract of Php 210,000.00;

WHEREAS, the procurement of Health Kits is necessary to comply with relevant issuances of oversight agencies and internal NPC policies regarding the health and safety of employees;

WHEREAS, said procurement is also necessary to ensure that all NPC employees are provided with immunity boosters and basic home remedy kits in case of sickness, particularly, Covid19;

WHEREAS, a Request for Quotation (RFQ) was posted in the PhilGEPS website and the NPC website, and was likewise sent to four (4) suppliers via electronic mail, namely: L. Victoria Trading, Silent Worker Marketing, DVK Philippines Enterprises, and Zioneyes General Merchandise. Three other suppliers, Affordacare Plus Trading, Philippine Vision Group and SGS Healthcare Co. submitted their quotations after seeing the postings;

WHEREAS, on 7 July 2022, the NPC Bids and Awards Committee (BAC) proceeded to evaluate the submitted quotations by Affordacare Plus Trading, DVK Philippines Enterprises, Philippine Vision Group and SGS Healthcare Co., and determined that DVK Philippines Enterprises is the supplier with the lowest calculated and responsive quotation;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of Health Kits to DVK Philippines Enterprises for being the lowest calculated and responsive quotation in the total amount of One Hundred Eighty Eight Thousand Pesos Eight Hundred Eighty (Php 188,880.00), subject to the presentation of their original documentary requirements upon signing of the Notice of Award (NOA)..


