**RECOMMENDING THE AWARD OF CONTRACT FOR
LOAD BALANCER (APP ITEM NO. 2021-0181)**

WHEREAS, the National Privacy Commission (*NPC* or *Commission*) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, it is the policy of the State that all resources of the government shall be managed, expended or utilized in accordance with law and regulations, and safeguarded against loss or wastage, with the aim of ensuring economy, efficiency and effectiveness in the operations of the government;

WHEREAS, with the increasing use of the Internet to support the day-to-day business-critical operations of the Commission, the need for reliable and well managed Internet connectivity is of great importance;

WHEREAS, the Interim Management Information Unit (IMISU) of the NPC proposed to acquire a load balancer device to aid in balancing network sessions and protocols over multiple connections to spread out the amount of bandwidth, thus increasing the network efficiency and the bandwidth available;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing as APP Item No. 2021-0181 (Load Balancer) in the FY 2021 Continuing Annual Procurement Plan (2021 Continuing APP) and with an Approved Budget for the Contract (ABC) amounting to Php 100,000.00;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" (RA 9184), recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52;

WHEREAS, a Request for Quotation (RFQ) was posted in PHILGEPS, the NPC website, and the NPC bulletin board and was likewise sent to five (5) suppliers, namely: IT Warehouse Enterprise Solutions, Mikrotik Philippines, Wireless Link Technologies, Inc., WizardTech PH, and Intellyx IT Solutions;

WHEREAS, one (1) bidder submitted its quotation: Next Generation Technologies Global, Inc.;






