RECOMMENDING THE AWARD OF CONTRACT FOR NPC PIN (APP ITEM NO. 2021-0235)

WHEREAS, the National Privacy Commission (*NPC* or *Commission*) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act (DPA) of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, in pursuit of achieving its vision as the world-class regulatory and enforcement agency upholding the right to privacy and data protection while ensuring the free flow of information and commitment to excellence, its newly-hired personnel should be given proper orientation as to the NPC, its structure, functions, and policies, roles and functions of individual members, among others;

WHEREAS, the procurement of NPC pin for the newly hired personnel to be given as part of said onboarding program was deemed necessary;

WHEREAS, this procurement has a Certification of Availability of Funds with APP Item No. 2021-0235 with an Approved Budget for Contract of Php 30,000.00;

WHEREAS, a Request for Quotation (RFQ) was posted at the PhilGEPS website with Reference No. 9291125 as well as at the NPC website, and was sent to the nine (9) suppliers, Best Choice Enterprises; Silent Worker Marketing; Ban Bee Commercial Co., Inc; Mostaco Marketing; Ceboom Enterprises; Zioneyes General Merchandise; DVK Philippines Enterprises; King of Kings. Trading; and Work Habits Trading;

WHEREAS, three suppliers, DVK Philippines Enterprises, Copy Master Tokens and Printing Services, and Grafiq Advertising System Corporation proceeded to submit their quotations as requested;

WHEREAS, on 9 December 2022, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) evaluated the submissions and determined that DVK Philippines Enterprises with a bid price of P29,688 as the single calculated and responsive quotation, and that it passed all the technical, legal, and financial requirements under RA 9184 and its 2016 Revised Implementing Rules and Regulations;


