Resolution No. 154-2022, Series of 2022

RECOMMENDING THE AWARD OF CONTRACT FOR PUBLICATION OF NPC ISSUANCES (APP ITEM NO. 2022-0075)

WHEREAS, the National Privacy Commission (NPC) is an independent body mandated to administer and implement the provisions of the Republic Act No. 10173 or the Data Privacy Act of 2012 (DPA) and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, Section 7 of the DPA charged NPC with the administration and implementation of the provisions of the law, which includes ensuring compliance with the provisions of the DPA and with international standards for data protection and carrying out efforts to formulate and implement plans and policies that strengthen the protection of personal information in the country, in coordination with other government agencies and the private sector;

WHEREAS, through its mandate to recommend and develop standards for organizational security measures for protection of personal information, the NPC, through the Privacy Policy Office (PPO or end-user), will be issuing the Circular on Guidelines for Private Security Agencies and the Circular on Amendments to Circular 20-01;

WHEREAS, pursuant to Section 18 of Executive Order No. 292, the end-user proposed the publication of the Circulars in one (1) newspaper of general circulation by 31 December 2022;

WHEREAS, this procurement has a Certificate of Availability of Funds under APP Item No. 2022-0075 with Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services as the mode of procurement and an Approved Budget for the Contract (ABC) amounting to Php220,000.00;

WHEREAS, Section 53.6 of the Revised IRR of Republic Act No. 9184 (RA 9184), otherwise known as the Government Procurement Reform Act, provides that goods and services can be contacted to a particular supplier if the requirement is for media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media;

WHEREAS, four (4) suppliers were asked to submit quotations. However, only three (3) entities namely: PhilSTAR Daily Inc., The Manila Times Publishing Corporation, and Philippine Daily Inquirer, Inc. proceeded to submit their quotations as requested;

WHEREAS, on 26 December 2022, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) evaluated the submissions and determined that the Manila Times Publishing Corporation with a bid price of P106,848.00 as the lowest calculated responsive

quotation and that it passed all the technical, legal, and financial requirements under RA 9184 and its 2016 Revised Implementing Rules and Regulations;
