**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF  
RENEWAL OF PHILIPPINE JURISPRUDENCE ONLINE ACCESS SUBSCRIPTION  
(2022-0019)**

---

**WHEREAS**, the National Privacy Commission (NPC or Commission) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 (DPA) and to monitor and ensure compliance of the country with international standards set for data protection;

**WHEREAS**, as general counsel of the NPC, the Legal Division (LD) is regularly consulted about legal matters and requested to issue legal opinions and contract reviews accordingly. In order to efficiently fulfill these tasks, the LD requires the acquisition of reliable sources such as laws, jurisprudence, and other issuances;

**WHEREAS**, the Policy Review Division (PRD), on the other hand, prepares advisory opinions on matters related to the interpretation of the DPA vis-à-vis other laws having privacy implication and/or with a perceived conflict with the DPA, reviews bills from Congress and provides comments or position papers to address the privacy implication of proposed legislations. Hence, in order to achieve the aforementioned, the PRD requires resources such as the online subscription of Philippine laws and jurisprudence;

**WHEREAS**, this procurement has a Certificate of Availability of Funds (CAF) and has been confirmed to be existing as APP Item No. 2022-0019 in the FY 2022 Annual Procurement Plan and with an Approved Budget for the Contract (ABC) amounting to Php250,000.00;

**WHEREAS**, Section 50 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Direct Contracting as a method of procurement when the item is sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the government or when the goods is of proprietary nature which can be obtained only from the proprietary source, i.e., when patents, trade secrets, and copyrights prohibit others from manufacturing the same item;

**WHEREAS**, based on the survey of the industry conducted by the end-users prior to the commencement of the procurement process, it was determined the CD Technologies Asia, Inc. is the only supplier which can provide the needs of the NPC, as stated in the end-users' Technical Specifications and no other suitable substitute in the market can be obtained at more advantageous terms;

**WHEREAS**, a Request for Quotation (RFQ) was sent to CD Technologies Asia, Inc;

**WHEREAS**, on 28 October 2022, the NPC-BAC proceeded to evaluate the submission by CD Technologies Asia, Inc. and determined that it passed the legal, technical, and financial requirement mandated by R.A. 9184 and its IRR;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for the procurement of Renewal of Philippine Jurisprudence Online Access Subscription to **CD TECHNOLOGIES ASIA, INC.** with Direct Contracting as mode of procurement, for having the single calculated and responsive quotation in the total amount of **Two Hundred Ten Thousand Five Hundred Sixty Pesos (P 210,560.00)**, subject to the presentation of their original documentary requirements upon signing of the Notice of Award (NOA).




