BAC Resolution No. 054-2023, Series of 2023

RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF ENDPOINT SECURITY SOLUTIONS (ANTI-VIRUS)

WHEREAS, the National Privacy Commission (NPC) is an independent body mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the Interim Management Information Unit (IMISU) of the NPC proposed the subscription to Endpoint Security Solutions (Anti-Virus) to secure and protect the NPC endpoint devices under APP Item No. 2023-0008 with an Approved Budget for the Contract (ABC) amounting to Seven Hundred Fifty Thousand Pesos (Php750,000.00) chargeable against ICT Software Subscription programmed under NPC CY 2023 APP;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR and provided, that in case of Goods, the procurement does not fall under shopping in Section 52 of the RIRR;

WHEREAS, a Request for Quotation (RFQ) was posted in PHILGEPS, the NPC website and the NPC Bulletin Board, and was likewise sent to several suppliers, namely: American Technologies, Inc., Next Generation Technologies Global, Inc., and Intellyx IT Solutions;

WHEREAS, pursuant to said request, the abovementioned entities submitted their quotations.

WHEREAS, the NPC Bids and Awards Committee (BAC) together with the BAC-Technical Working Group (TWG) proceeded to evaluate the bids submitted. The BAC-TWG, in an email dated 5 July 2023 found that both American Technologies, Inc., and Intellyx IT Solutions only offer Endpoint Detection & Response (EDR) capabilities and not Extended Detection & Response (XDR)¹ as required under the Technical Specifications. XDR provides more robust capabilities in malware detection and anti-virus capabilities;

WHEREAS, the BAC further evaluated the eligibility documents submitted and determined that only Next Generation Technologies Global, Inc. complied with the technical, legal, and financial requirements under RA 9184, making it the single calculated and responsive quotation at a bid price of Php 749,822.43 within the ABC;
