TECHNICAL SPECIFICATION

PLAQUES (APP Item No. 2023 - 0033)

I. BACKGROUND

The National Privacy Commission (NPC) is the country's privacy watchdog: an independent body mandate to administer and implement the Data Privacy Act of 2021 and to monitor and ensure compliance the country with international standards set for data protection. The law was passed in 2012, but it was only in 2016 that the first Privacy Commissioner was appointed, and the secretariat was formed.

Recognizing and rewarding employees for their dedication and contributions is an important practice for maintaining motivation and fostering a positive work environment. The Policy Guidelines on Awards and Incentives for Service Excellence (PRAISE) is a structured and fair way to acknowledge the efforts of deserving employees. Providing both monetary and non-monetary incentives is a thoughtful approach as it caters to various types of recognition that employees might appreciate.

II. OBJECTIVES


