BAC Resolution No. 114-2023, Series of 2023

**RECOMMENDING THE AWARD FOR THE PROCUREMENT OF  
COMMON-USE OFFICE SUPPLIES NOT AVAILABLE @ PS DBM  
(APP Item No. DSPQR 2023-0013)**

---

**WHEREAS**, the National Privacy Commission (NPC) is the agency mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

**WHEREAS**, Section 6, III (n) of R.A No. 10844 directs the DICT to ensure and protect the rights and welfare of consumers and business users to privacy, security and confidentiality in matters relating to ICT, in accordance with agencies concerned, the private sector and relevant international bodies;

**WHEREAS**, the Republic Act. No. 10173 or the "Data Privacy Act of 2012" designates the NPC to administer and implement the provisions of the Data Privacy Act (DPA), and to monitor and ensure compliance of the country with international standards set for data protection, that is hereby created an independent body to be known as the National Privacy Commission;

**WHEREAS**, NPC and DICT have agreed to work together on the successful deployment of the Digital Security and Privacy Quick Response (DSPQR) Project pursuant to MOA signed on 25 October 2023 and notarized on 28 October 2023 which will be procured and implemented by the NPC and integrated to current applications of the Government Digital Transformation Bureau;

**WHEREAS**, to ensure the smooth operations and achieve the utmost objective of the said project the NPC is mandated to provide equipment, supplies and materials required for meeting the objective of the project;

**WHEREAS**, the NPC approved the Digital Security and Privacy Quick Response (DSPQR) Project FY2023 APP which includes the procurement of Common-Use Office Supplies not available @ PS DBM with APP Item No. DSPQR 2023-0013 with an Approved Budget of the Contract of TWO HUNDRED FIFTY FIVE THOUSAND PESOS (Php255,000.00) charged against Office Supplies Expenses (OPERATIONS-MOOE);

**WHEREAS**, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" (RA 9184), recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H " of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52;

**WHEREAS**, on 12 December 2023, a Request for Quotation (RFQ) was posted at the PhilGEPS website and at the NPC website. It was likewise sent to five (5) suppliers namely: (1) Token

Avenue Trading, (2) King of Kings Trading, (3) Silent Worker Marketing, (4) A4 Luck Marketing Corp., (5) Zioneys GenMdse;

**WHEREAS**, on 19 December 2023, the National Privacy Commission - Bids and Awards Committee (NPC-BAC) proceeded to evaluate all the submitted quotations and determined that only Silent Worker Marketing, has passed the technical, legal, and financial requirements mandated under RA 9184;

**WHEREAS**, Silent Worker Marketing was determined to have submitted the single calculated and responsive bid at a bid price of Php253,128.00;

**WHEREAS**, on 19 December 2023, the National Privacy Commission - Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotation by King of Kings Trading, identified that it passed the technical, legal and financial requirements mandated under RA 9184 and its IRR, and determined that **Silent Worker Marketing** submitted the single calculated and responsive quotation at a bid price of Php253,128.00;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award for the procurement of **COMMON-USE OFFICE SUPPLIES NOT AVAILABLE @ PS DBM** in the total amount of **TWO HUNDRED FIFTY-THREE THOUSAND ONE HUNDRED TWENTY-EIGHT PESOS (Php253,128.00)** to **SILENT WORKER MARKETING** for being the lowest calculated and responsive quotation and be subject to the presentation of their original documents upon signing of the Notice of Award (NOA).


