**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF
PLAQUES (APP Item No. 2023-0033)**

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the NPC workforce has been working towards the organization's vision to be a world class regulatory and enforcement agency, upholding the right to privacy and data protection while ensuring the free flow of information and commitment to excellence;

WHEREAS, the Policy Guidelines on Program on Awards and Incentives for Service Excellence (PRAISE) of the NPC under Commission Order No. 010, s. 2021 aims to encourage, recognize, and reward employees for their innovative ideas, inventions, discoveries, superior accomplishments, heroic deeds, exemplary behavior, extraordinary acts of service in the public interest, and other personal efforts that contribute to the efficiency, economy, and improvement of government operations which lead to organizational productivity;

WHEREAS, PRAISE is a structured and fair way to acknowledge the efforts of deserving employees. Providing both monetary and non-monetary incentives is a thoughtful approach as it caters to various types of recognition that employees might achieve;

WHEREAS, the Human Resource Development Division (HRDD) proposed to procure plaques, as part of the non-monetary incentives, to serve as a memoir to strive harder, pursue excellence and continue personal development;

WHEREAS, the NPC approved its FY 2023 Annual Procurement Plan (APP) which includes the procurement of Plaques with APP Item No. 2023-0033 with an Approved Budget of the Contract amounting to FIFTY THOUSAND PESOS (Php50,000.00) chargeable against Training Expenses (GAS-MOOE);

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" (RA 9184), allows Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H " of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52;

WHEREAS, on 10 November 2023, a Request for Quotation (RFQ) was posted on PhilGEPS website and at the NPC website. It was likewise sent to five (5) suppliers namely: (1) Grafiq Advertising System Corporation; (2) Token Avenue Trading; (3) King of Kings Trading; (4) Work Habit Trading; and (5) CopyMaster Tokens and Printing Services;

WHEREAS, two (2) bidders submitted their quotations namely: (1) Grafiq Advertising System Corporation, and (2) Token Avenue Trading;

WHEREAS, on 17 November 2023, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) proceeded to evaluate all the submitted quotations and determined that only Grafiq Advertising System Corporation has passed the technical, legal, and financial requirements mandated under RA 9184;

WHEREAS, Grafiq Advertising System Corporation was determined to have submitted the lowest calculated and responsive quotation at a bid price of Forty-Four Thousand Seven Hundred Fifty Pesos (Php44,750.00);

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award of contract for the procurement of **PLAQUES** in the total amount of **FORTY-FOUR THOUSAND SEVEN HUNDRED FIFTY PESOS (Php44,750.00)** to **Grafiq Advertising System Corporation** for being the lowest calculated and responsive quotation, subject to the presentation of their original documents upon signing of the Notice of Award (NOA).
