RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF E-NGAS & E-BUDGET PROJECT (INTERNAL HDD) (APP Item No. 2023-0074)

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the Commission on Audit issued guidelines requiring the adoption and implementation of the Enhanced Electronic New Government Accounting System (eNGAS) and Electronic Budget System (eBudget);

WHEREAS, this procurement of internal HDD aims to enhance the data retention and maintenance capabilities of the NPC, so as to ensure the seamless operation of the eNGAS and eBudget system of the Financial, Planning and Management Division (FPMD) through the recommendation of the NPC-IMISU;

WHEREAS, the NPC approved its FY 2023 Annual Procurement Plan (APP) which includes the procurement of e-NGAS & e-Budget Project (Internal HDD) under APP Item No. 2023-0074, with an Approved Budget for the Contract of FIFTY-FIVE THOUSAND PESOS (Php55,000.00) charge against Semi-Expandable - ICT Equipment (GAS-MOOE);

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" (RA 9184), allows Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52;

WHEREAS, on 03 November 2023, a Request for Quotation (RFQ) was posted on PhilGEPs, NPC website, and NPC bulletin board. The same was likewise sent to eight (5) suppliers namely: (1) IConnect Technologies, Inc.; (2) Micro Image International Corporation; (3) RS Components Corporation; (4) Next Generation Technologies Global, Inc.; (5) Intellyx ICT Solutions;

WHEREAS, five (5) bidders submitted their quotations namely: (1) BayanPC Technologies, Inc.; (2) Iconnect Technologies, Inc.; (3) METOS Offshore, Inc.; (4) Proximatech Solutions Company; and (5) Bridgeway communications System Inc;

WHEREAS, on 13 November 2023, the National Privacy Commission - Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted bids and determined that **Bridgeway Communications System Inc.** is the lowest calculated and responsive quotation at a bid price of Forty-Eight Thousand and Fifty-Eight Pesos (Php48,058.00);

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby **RESOLVED**, to recommend the award of contract for the procurement of **E-NGAS & E-BUDGET PROJECT (INTERNAL HDD)** to **Bridgeway Communication System, Inc.**, for having the lowest calculated and responsive quotation in in the total amount of **FORTY-EIGHT THOUSAND FIFTY-EIGHT PESOS (Php48,058.00)**, subject to the presentation of their original documentary requirements upon signing of the Notice of Award (NOA).




